



**CODE OF FRANKLIN TOWNSHIP: 173:1, Markets and Sales Along Route 30**  
**Franklin Township Yard Sale and Flea Market Permit Application**  
**P.O. Box 309, Cashtown, PA 17310**

- § 173-5 No permit shall be issued by the Zoning Officer unless the applicant has proven compliance with the following:
- A. There is sufficient off-street parking available on the owner's property to accommodate all of the vehicles reasonably expected to be stopped at the site at any given time;
  - B. That the access to the parking area is by way of a driveway or access road recognized by the Pennsylvania Department of Transportation as a permitted driveway or accessway;
  - C. An assurance from the applicant that there will be compliance with the provisions of the Zoning Ordinance regulating signs.

Applicant shall provide a copy of a Penn DOT approved Highway Occupancy Permit or Penn DOT verification for the driveway or accessway. Please contact Penn DOT if you do not have a copy of your driveway highway occupancy permit or do not know if your driveway is permitted and approved. **A Yard Sale/Flea Market Permit will not be approved without this verification.**
