#### **Gate of Dawn Subdivision**

- The planning commission reviewed comments to the Gate of Dawn Subdivision from Adams County, KPI, and PMCA. Multiple issues from the comments remain outstanding from the current plan. Much of the discussion centered on the location of a potential home or dwelling, and the subsequent and/or potential costs and requirements for a given location. Multiple members expressed concern that an approved plan, depending on the notional depiction of a homesite location, may unintentionally signal to an unknowing landowner that a notional depiction is otherwise approved for actual building or development.
- MOTION to RECOMMEND CONDITIONAL APPROVAL of the Gate of Dawn Subdivision request, pending resolution of outstanding items to the satisfaction of the zoning officer and township engineer, by Eric Miller, seconded by Gary Deardorff.
- Further, the planning commission notes special concerns over the following three items:
  - the notional location of the homesite and the potential for prospective future developers to infer this notional location as approval for development;
  - that proposed driveways do not appear to have adequate site distance, based on assumed speed limit; and,

- the plan does not include a shared driveway, and therefore each lot may require a NPDES permit for erosion and sedimentation control and stormwater management.
