# **Board of Supervisors Workshop Meeting**

The workshop, held at the Franklin Township Municipal Building, was called to order at 7:00 p.m. by Chairman Crushong

## Tractor - Municibid

Curt MacBeth, Roadmaster informed the Board that Municibid's final bid was \$48,000.00 on the Tractor and it did not meet the reserve that the Township had set for it. Curt MacBeth, Roadmaster further informed the Board that he received a call from a Township in Vermont after he left the office today and they may be willing to give the Township the full \$75,000.00 for the tractor. They wanted to know what was wrong with the tractor and Curt explained everything to them and they are interested in it but they cannot make a decision until Monday.

MOTION by Supervisor Santay, seconded by Supervisor Williams to give Curt MacBeth, Roadmaster to sell the 2018 John Deere Tractor for \$75,000.00 to a Municipality in Vermont with a commitment by 4:00 pm on Monday, March 25, 2024 at which time the Township will reject the Municipid offer but, if this offer does not develop then accept the \$48,000.00 Municipid Bid. Motion carried, 3-0.

# 52 Pheasant Trail - Gettysburg Hunting Club - Permanent Residence

Susan Plank, Secretary/Treasurer informed the Board that she pulled the file and had Solicitor Yannetti review and it appears that 52 Pheasant Trail was originally supposed to be a permanent resident but it was missed on the original agreement.

MOTION by Supervisor Williams, seconded by Supervisor Santay to approve the permanent residency at 52 Pheasant Trail at the Gettysburg Hunting Club. Motion carried, 3-0. T

# World T.E.A.M Bicycle Ride – April 21, 2024

Susan Plank, Secretary/Treasurer informed the Board that the Township had everything needed for this Bicycle Ride from Washington DC to the WWII Museum on Crooked Creek Road.

MOTION by Supervisor Santay, seconded by Supervisor Williams to approve the World T.E.A.M. Bicycle Ride from Washington DC to the WWII Museum using Mummasburg Road to Crooked Creek Road. Motion carried, 3-0.

Susan Plank, Secretary/Treasurer informed the Board that the Comcast Franchise agreement is due for renewal and that Solicitor Yannetti has reviewed the Contract and there were no significant changes.

MOTION by Supervisor Williams, seconded by Supervisor Santay to approve the Comcast Franchise Agreement for another ten (10) years with a 3% Franchise Fee. Motion carried, 3-0.
