## PLEDGE OF ALLEGIANCE

#### Byers – 495 Old Route 30 – Land Development

Mr. Byers requested a waiver from doing to Land Development Plan on the basis that USDA and NRCS wants the cows move out of and not in front of the White Barns that is existing on the property.

MOTION by Supervisor Williams, seconded by Supervisor Santay to approve sending RPF's for a New CPA to complete audits for the Township. Motion carried, 3-0.

Curtis MacBeth, Roadmaster informed the Board that Joe Ney, M&K Truck Center wants to know if the Township still wants the new trucks. Supervisor Williams asked what the cost would be and Curt replied that he did not know but would get the information together. The Board is still interested in purchasing trucks but would like more information.
