**MOTION by Supervisor Williams, seconded by Supervisor Santay to approve Land and Sea's 2020 fee schedule as reviewed at the December 19, 2019 Workshop. Motion carried, 3-0.**

**MOTION by Supervisor Santay, seconded by Supervisor Williams to approve KPI Technology's 2020 fee schedule as reviewed at the December 19, 2019 Workshop. Motion carried, 3-0.**

**MOTION by Supervisor Santay, seconded by Supervisor Williams to establish the 2020 holidays observed for the Township employees as follows: January 1, 2020 – New Year's Day, February 17, 2020 – Presidents Day, April 10, 2020 – Good Friday, May 25, 2020 – Memorial Day, July 3, 2020 – Independence Day, September 7, 2020 – Labor Day, October 12, 2020 – Columbus Day, November 11, 2020 – Veterans Day, November 26, 2020 – Thanksgiving, and December 25, 2020 – Christmas. Motion carried, 3-0.**
