

**Franklin Township, Adams County
Board of Supervisors Workshop Meeting**

January 16, 2020

SUPERVISORS PRESENT: Henry Crushong, Jr., Chris Santay, and Matt Williams

OTHERS PRESENT: Susan Plank, Secretary/Treasurer

The workshop, held at the Franklin Township Municipal Building, was called to order at 7:00 p.m. by Supervisor Crushong.

PUBLIC COMMENT OF AGENDA ITEMS ONLY

Resident Pat O'Shea commented on the Military Museum that will be built on Crooked Creek Road. His concern is the traffic impact on Crooked Creek Road. He has addressed this several times and just wanted to voice his opinion that he feels a Traffic Study needs to be done. He was at the Planning Commission meeting last evening and what he found out that a Traffic Analysis was completed and that the Bucks are requesting a waiver from the Traffic Impact Study. He also wanted to bring to the Board's attention an area on Crooked Creek Road in front of 90 Crooked Creek Road that caused his wife's car to bottom out. He has made several calls on this before and it has not been taken care of. Supervisor Santay informed Mr. O'Shea that the Township will have the roadmaster look into this.

Mr. John Murphy – Jeff Richards

Mr. Murphy presented a letter from Mr. Bob Sharrah concerning the impervious surface and the stormwater management issue. Mr. Murphy offered a settlement to the Board based on the letter from Mr. Sharrah. The brief has been postponed until February 17th but he did inform the Board that both Solicitor Yannetti and himself will need time to draft their briefs so he would like a decision as their earliest convenience. The Board will take this under consideration.

Representative Moul – MS4 / Stormwater

Representative Moul presented the Board with his thoughts on MS4 and the impact that it has on the Borough/Municipality that has gotten the notice that they need to comply. Representative Moul is not in favor of MS4. There has been no evidence, in his opinion, that things are improving with enforcing MS4. There is a lot of cost for the Borough/Township and this is an engineer's dream. Representative Moul gave the Board of Supervisors a copy of a Public Statement from Antrim Township and Greencastle Borough that was addressed to several Representatives, Congressmen and the Citizens of Greencastle-Antrim and Franklin County making motion that all MS4 stop until MS4 can be clarified. There was much discussion on MS4 and what it will cost the Township. Supervisor Williams asked Representative Moul about Stormwater and Representative Moul replied that he does not know much about stormwater management.

6-month probation for Kevin Bonk

Susan Plank, Secretary/Treasurer informed the Board that Kevin Bonk has completed his 6-month probation period. The Board informed Susan Plank to look at how much increase was Kevin Bonk told he would receive after his 6-month probation period and see to it that he gets this on his next paycheck.

240 Oak Drive – Inoperable Vehicles

Susan Plank, Secretary/Treasurer informed the Board that Brian Clevenger one of the owners of 240 Oak Drive has been incapacitated. Land and Sea has issued inoperable vehicle citations to Mr. Clevenger but he has been adjudicated incompetent and unable to address the problem. The Board would like to contact Solicitor Yannetti to ask if Land and Sea can cite Ms. Kimberly Clevenger for the violations since her name is on the property.

Kalathas Mini Storage Units – Paperwork

Susan Plank, Secretary/Treasurer informed the Board that the Township has received the paperwork from Kalathas that they have sent all the necessary information to PennDOT and are waiting on their final paperwork.

545 Crooked Creek Road – KPI Traffic Study Review

Susan Plank, Secretary/Treasurer asked the Board if the Township wanted KPI to have their Engineer review the Traffic Analysis for 545 Crooked Creek Road. Supervisor Crushong informed everyone that the Planning Commission is still working on the impact that the traffic will have on Crooked Creek Road and that the Township has not granted any of the waivers that the Buck's are asking for as of yet. The Buck's and their Engineer are clear of what is expected from the Township concerning the Traffic Study.

Ordinance wording changes – Weeds

Susan Plank, Secretary/Treasurer informed the Board that the Township has received an email from Mr. Barber regarding the changes to Ordinance 65 Section 65-4 E. She informed the Board that she had sent a copy of his email to Solicitor Yannetti for review.

400 Church Road – Administrative Search Warrant

Supervisor Santay would like an update from Gil concerning DEP looking at this residence. Susan Plank, Secretary/Treasurer informed the Board that the Township did in fact receive an email from Bryan Walter, DEP Representative and she called Mr. Walter and he informed her that since the Township has their Zoning Officer working on the situation then DEP will not get involved as long as the Township is enforcing their ordinance.

Truck Leasing

The Board would like the Township to look at Enterprise to see what kind of Leasing deals they may have. Supervisor Crushong asked if Curt talked to Gettysburg or Cumberland concerning their leasing and who they lease from. Susan Plank did not know if he had talked to either but would ask him about this.

Supervisor Santay asked Susan Plank, Secretary/Treasurer if she made a note for them to look at 90 Crooked Creek Road concerning the comment from Mr. Pat O'Shea. Susan replied that she has the note and will ask them to look at it tomorrow.

Susan Plank, Secretary/Treasurer gave the Board a map of the Township that was received through the mail from the Census Bureau requesting that the Board look at and make sure the boundaries were properly marked. The Board agreed that the boundaries were correct.
