Board of Supervisors Workshop Meeting

November 21, 2024

SUPERVISORS PRESENT: Supervisor Crushong and Supervisor Santay. Supervisor Williams was absent.

OTHERS PRESENT: Gil Picarelli, KPI Technologies and Susan Plank, Secretary/Treasurer

The workshop, held at the Franklin Township Municipal Building, was called to order at 7:00 p.m. by Vice-Chairman Williams.

Gettysburg Hunting Club – Permanent Resident Request

Gil Picarelli, KPI Technologies addressed the Board letting them know that the Township has had a request to add another address as a permanent residence at the Gettysburg Hunting Club. Gil informed the Board and showed them a copy of a letter that was drafted in 2008 concerning this matter. He also suggested that the Township not approve any additional permanent residencies at the Club. The Board of Supervisors would like Solicitor Yannetti to send a letter to the President of the Hunting Club along with a copy of the letter from 2008 stating that the Township will not approve any further permanent residents at this location.
