## June 2020 Road Crew Report

- June 1 removed limb hanging on Boyer's Nursey Road, finished getting Ragged Edge Road ready for tar-chipping, mowed grass at twp. building
- June 2 went over unit # 9 and 12 for inspection, put 2A/regraded Flohrs Church and Winding Road, cut spot out on Sunset Road
- June 3 put black top in tile crossing/pot holes, put mower back together, mowed along roads
- June 4 mowed along roads, cleaned unit # 1 and 14 for paving, picked supplies up at Dollar Store, took unit #12 to Action Truck for inspection, fixed ABS on unit #14, took pans from unit #12 and 15 to Mortiz Machine to be fixed, cleaned side ditch on Green Ridge Road
- June 8 meet with Danny Feters and Interstate door company about upper building, took unit #14 to Penn Dot about GL system, Shred-it in to shred old documents, mowed along roads, dressed up places due to heavy rains over the weekend, mowed grass at twp. building, switched truck out for inspection at Action Truck
- June 9 mowed along roads, fixed speed limit sign on Boyer's Nursery Road, cut limbs at intersections for sight distance, sweep Jack Road, picked truck up at Action from inspection, marked sinking/soft spot on White Pine Drive
- June 10 mowed along roads, cut spot on White Pine Drive and called pa 1 call, cut tree on Old Route 30, gathered guard rail up from bridge on Casktown Road and brought back to shed, cut side ditch on Green Ridge Rd
- June 11 mowed along roads, Dave's Truck Repair towed unit #6 to Penn Power Group, cut side ditch on Green Ridge Road, Hammaker in to tar-chip, meet with AAA about paving
- June 12 Hammaker in to finish tar-chipping
- June 15 started to pave Jack Road
- June 16 finished paving Jack Road
- June 17 paved New and Church Road
- June 18 mowed along roads, cleaned unit # 1 and 14, mowed grass at twp. building, picked pans for unit # 12 and 15 up at Mortiz Machine & Repair, ordered rename signs, picked unit #6 up at Penn Power Group, installed chipper unit #15
- June 22 paved Winding and Flohrs Church
- June 23 paved Ragged Edge Road, meet with Buck's on Crooked Creek Road in regards to museum, mowed along roads, cleaned unit #1 & #14 from paving, installed berm machine unit #14
- June 24 fixed drive entrances/berm on Church, New Roads, Flohrs Church, and Winding Road, mowed along roads, mowed grass at twp. building, picked tires up at Mar-Bar Tire for unit #1
- June 25 went to J&J for prebuild meeting for bucket truck, mowed along roads
- June 29 mowed along roads, replaced rear tire unit #1, NAPA for supplies, replaced stop sign and road name at Bridgeport and Narrows Road
