Flohers Church Road (Dirt Section) at Peter's Orchard – 2<sup>nd</sup> Driveway – Texas Eastern Transmission Pipe Line

The Board of Supervisors would like a protective/ hold harmless clause drafted to protect the Township is there is a need to work in the right of way. The Board of Supervisors also wants the project bonded.
