- Special Exception Application 980 Flohrs Church Road
 - Applicant Daniel Wood presented a request for a special exception to convert a residential property into a short-term rental. After discussing the township's zoning definitions—which currently do not include short-term rentals—and learning that a rooming house may be the most applicable use under current ordinances, Mr. Wood opted to table the application. He indicated he would consult legal counsel and return with a revised application that better aligns with existing zoning designations.

- Variance Application: 2408 Chambersburg Road

- Representatives of the solar project at 2408 Chambersburg Road requested two variance requests related to the solar energy facility previously approved via conditional use. The first variance sought relief from the requirement to construct a 25-foot-wide paved access drive, proposing instead a 16-foot-wide gravel drive intersecting a private drive. The second variance concerned the spacing between solar panel rows; the applicant requested a reduction from the required 20 feet to 8.45 feet to preserve more farmland.
- MOTION: The Planning Commission RECOMMENDS APPROVAL of the variance request of a 16-foot-wide gravel drive instead of a 25-foot-wide paved drive, provided a new Operations & Maintentance agreement for the road is completed, by Gary Deardorff, seconded by Dale Graves.
 - MOTION APPROVED 6-1.
- MOTION: The Planning Commission RECOMMENDS APPROVAL of the variance of the spacing between solar panel rows, a reducution from 20 feet to 8.45 feet, by Gary Deardorff, seconded by Eric Miller.
 - MOTION APPROVED UNANIMOUSLY.
