Brightspeed

No Update

Mr. Deardorff commented that they were suppose to be there today but they canceled out today again. Roadmaster Curt MacBeth commented that the line guy from Brightspeed talked to them up on New Road and told them that Brightspeed is no longer coming out and marking the lines for 811. Brightspeed figures it is cheaper to come out and repair and they are doing is they will wait about 6 months to a year and they will send a bill for the repairs hoping you forgot about calling 811 to have it marked. Curt MacBeth, Roadmaster commented that you need to keep a copy of the PA One call and pictures that shows that you called in so that you have proof that it was indeed called in.

NEW BUSINESS

GUESTS

Resident Darrin Flake commented that he commends the Township for accomplishing a lot as a whole this year.

Resident Doug Glass ask if he could comment on the Zoning Hearing that happened on December 3, 2026. Supervisor Santay commented that they would listen to his comments but the decision was with the Zoning Hearing Board. Mr. Glass asked how many members are on the Zoning Hearing Board and Supervisor Santay commented that there were three (3) members

and one (1) alternate on the Zoning Hearing Board. Mr. Glass said that Solicitor Beaton did a very good job. Solicitor Beaton pointed out that the request did not meet the five (5) criteria for be approved. Mr. Glass commented that Solicitor Beaton and the Planning Commission did not recommend approval of the variance but the Zoning Hearing Board approved it. He questioned the Township spending funds on lawyers when we are not going to listen to legal counsel. He thought the Board was not representing the Township but were representing private interest. He also commented that two (2) members had no questions for clarification and he believes that when they walked through the door, they knew how they were going to vote. He continued that everyone in the room knows that he has not been in favor of this project. Mr. Glass commented that he never ever felt that the three (3) Supervisors have been unfair, you three (3) have a tough job. Mr. Glass commented that he doesn't always agree with the Board but he believes that they have been as fair as they can be. He did not get that feeling last night.
